Local Offer Website

As you may already be aware the Local Offer Website is being reviewed and updated. Part of this process has been participating in a peer review with neighbouring regions. The Local Offer website was reviewed by Derbyshire who shared some positive feedback as well as some minor changes that could be made.


Changes have been made to make it more accessible, including using some symbols and clearer simpler language. The Local Offer website was recently reviewed By Charlie Palmer from the DfE who said the accessibility aspects were the best in the country.

Additional information has been added from Health and new independent services registering their information. At the same time current service information and provision is being reviewed and updated.

The website retains a vast amount of information and hence this process can take time. If your service information is advertised on this website, please do check that you are happy with it, or if there are any changes to be made please forward them using the email address below or the link on "You said we did" to ensure the Local Offer Website is kept up to date and current.

EHC Professional Portal

Some of you will be aware that LCC has invested in a new portal that will make the Statutory Assessment and plan writing process easier for all those involved. The current process requires advice givers, schools, educational phycologist, health, social care, to send written reports to staff in Special Education Service who then upload advice onto the ONE system. Often these are typed up from hand written notes taken when meeting with the child and their family

The new system will allow professionals to input their advice directly into the system using an online form. It can be accessed via computer, tablet and mobile phone allowing advice givers to type their notes directly into the system wherever they are. They can be finalised later and then submitted for upload to the plan. Once they have been submitted to the SES team they will be collated (in sections where there are more than one advice giver) and uploaded to the plan.



The new system should bring several benefits including:

- Advice givers can see all advice on a child that they are working with enabling effective multi agency working
- Process will be quicker, and timescales will be visible
- System provides prompts when information required, or new plans uploaded
- Documents can be uploaded and shared
- Draft plan can be seen at any time
- Increased Data security; access to the plan is via the portal using a twostep verification process
- Can specify who can see shared information
- Can give varying levels of access to information that can be viewed
- Parents, Carers and children are engaged in the process and able to participate through a Citizen portal

We are currently working our way through internal training and testing which will be completed by the end of April. We will then pilot the system in the NE of the city commencing in May and expect to roll it out across the whole city in September. Look out for further updates in future newsletters.

Quality Assuring EHC plans

As you may recall one of the areas of criticism in the Local Area Review was the quality of our EHC plans and the lack of process for quality assuring them. As a result, and with the help of our performance team we have developed a new toolkit like that used by children's social care. The toolkit uses questions developed by Mott Mac Donald, approved by the DfE for quality assuring EHC plans. The toolkit is an interactive tick box questionnaire with embedded guidance that is sent each month to our 35 auditors along with an anonymised plan for them to audit. It also allows free text for auditors to commend best practice or highlight concerns.

Once returned all plans that fall below the expected pass rate are moderated by a separate group of managers. In addition, a sample of 10% of those plans that pass are also moderated. Any plans that do not have social care or health needs and provision automatically fail and will be escalated back to the service in question through a senior manager. Failure in other areas will also be escalated as required. Any trends either good or bad will be fed back to advice givers to ensure continuing improvement.

Over the next 12 months we need to quality assure as many of the 2400 plans that we currently have as possible. For that reason, we would like to ask SENCO's to make quality Assurance part of the annual review process and will be discussing this we hope at the SENCO meeting in June.

The process will run alongside the annual review and use the toolkit already developed. We would hope to roll it out in September but would be very keen to hear from any SENCO that would like to start looking at the quality process now. Preparing for Adulthood and SEND Strategy

The transition from secondary school to college can be a daunting experience for young people with SEND needs. Young people may be highly anxious of moving to another setting with new staff teaching them as well as having to make some new friends and adapt to a new setting and rules and routines. Just actually getting to the placement can be a huge step for them as well. And then there is the actual learning.

A pilot project is currently being set up to look at the transition process and how to ensure that the young people are supported through the process and information is shared in a timely manner to ensure a smooth transition.



This pilot project is bringing together mainstream, special schools and colleges, to look at the transition process, time line and tools needed to ensure a smooth transition for young people with SEND.

Update on Designated Specialist Provision

Colleagues will be aware of our plans to develop a number of additional places in Designated Specialist Provision (DSP) in mainstream schools across the city. The current position is that the paper outlining those schools who will be supported to open a DSP in the school's year 2019/20 is in the Council's decision making process and a decision is expected very shortly.

It is hoped to have a number of DSPs open in autumn term, but it is recognised that recruitment and building issues may mean this date is moved to later in the term or academic year. Heads of those schools put forward to be in the first wave will receive a letter outlining the proposed action plan shortly. Please be assured to the commitment to deliver the additional places we require for our children in Leicester City. We will be in touch with colleagues as soon as we can.
